3. successive purchases of an aggregate of 29,400,000 Shares in the price range of HK\$3.51 to HK\$4.03 per Share (exclusive of brokerage fee of 1.0%, SFC transaction levy of 0.003% and Hong Kong Stock Exchange trading fee of 0.005%) on the market during the stabilizing period, representing approximately 15% of the Offer Shares initially available under the Global Offering before any exercise of the Over-allotment Option. The last purchase made by the Stabilization Manager on the market during the stabilizing period was on July 2, 2014 at the price of HK\$3.95 per Share (exclusive of brokerage fee of 1.0%, SFC transaction levy of 0.003% and Hong Kong Stock Exchange trading fee of 0.005%).

The Over-allotment Option had not been exercised by the Joint Global Coordinators (on behalf of the International Underwriters) during the stabilizing period and lapsed on July 23, 2014.

3. successive purchases of an aggregate of 29,400,000 Shares in the price range of HK\$3.51 to HK\$4.03 per Share (exclusive of brokerage fee of 1.0%, SFC transaction levy of 0.003% and Hong Kong Stock Exchange trading fee of 0.005%) on the market during the stabilizing period, representing approximately 15% of the Offer Shares initially available under the Global Offering before any exercise of the Over-allotment Option. The last purchase made by the Stabilization Manager on the market during the course of the stabilizing period was on July 2, 2014 at the price of HK\$3.95 per Share (exclusive of brokerage fee of 1.0%, SFC transaction levy of 0.003% and Hong Kong Stock Exchange trading fee of 0.005%). The 29,400,000 Shares purchased on the market during the stabilizing period will be applied for the purposes of covering over-allocations under the International Placing.

## LAPSE OF OVER-ALLOTMENT OPTION

The Company further announces that the Over-allotment Option had not been exercised by the Joint Global Coordinators (on behalf of the International Underwriters) during the stabilizing period and the Over-allotment Option lapsed on July 23, 2014. Accordingly, no Share was issued under the Over-allotment Option.

The Company continues to comply with the public float requirements under Rule 8.08(1)(a) of the Listing Rules.
