VOLUNTARY ANNOUNCEMENT COOPERATION AGREEMENT WITH PPLIVE INC.

On 9 November 2015, our subsidiaries Beijing Lianzhong Co, Ltd. (“**Beijing Lianzhong**”) and Tianjin Zhongqi Weiye Sports Development Co., Ltd. (天津中棋惟業體育發展有限公司) (collectively “**Lianzhong**”) entered into the internet copyright cooperation agreement (the “**Agreement**”) with PPLive Inc. (上海聚力傳媒技術有限公司) (“**PPTV**”). The expiration date of the Agreement is 31 December 2017.

Under the Agreement, on the basis that PPTV pays Lianzhong the applicable fees, PPTV will enjoy the following rights within the People’s Republic of China (excluding Hong Kong, Macau and Taiwan):

- exclusive information network communication rights (meaning the right to deliver programs to specific or non-specific persons through internet technology, including but not limited to live broadcast and taped broadcast) of the “Five Chess and One Bridge” tournaments (「五棋一牌」賽事), as well as Beijing Lianzhong’s competitions (meaning the 2015 World Mahjong Sports Games and the 2015 World Computer WeiQi Tournaments) on PPTV’s PC and mobile platforms;
- non-exclusive information network communication rights of the “Five Chess and One Bridge” tournaments and Beijing Lianzhong’s competitions on PPTV’s Internet TV platform; and

- non-exclusive information network communication rights of Beijing Lianzhong’s programs (meaning Lianzhong Chess Class and Human vs Computer Chess) on PPTV’s platforms, excluding PPTV’s Internet TV platform.
