#### **CHANGE IN SHAREHOLDING OF SUBSTANTIAL SHAREHOLDERS**

This announcement is made by Ourgame International Holdings Limited (the “**Company**”) pursuant to Rule 13.09(2)(a) of the Rules Governing the Listing of Securities (the “**Listing Rules**”) on The Stock Exchange of Hong Kong Limited and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The Company was notified on 20 October 2025 that, according to the relevant disclosure of interests notices made on 17 October 2025 by Mr. Li Yangyang and Choi Shun Investment Limited, a corporation controlled by him (collectively, “**Mr. Li and Choi Shun**”), Mr. Li and Choi Shun had disposed of an aggregate of 178,758,328 shares in the Company (the “**Shares**”), representing approximately 16.59% of the total issued Shares as at the date of this announcement. Furthermore, Mr. Li and Choi Shun have also ceased to have the right to exercise voting rights in respect of an aggregate of 111,923,887 Shares (representing approximately 10.38% of the total issued Shares) and have terminated the acquisition of 28,620,378 Shares (representing approximately 2.66% of the total issued Shares).

On the same date, according to the relevant disclosure of interests notices made by Spark Holdings Limited (“**Spark**”), Spark had acquired an aggregate of 322,807,225 Shares, representing approximately 29.95% of the total issued Shares.

Following the aforesaid shareholding changes, Mr. Li and Choi Shun do not hold any Shares and have ceased to be a substantial shareholder of the Company (as defined in the Listing Rules), while Spark has become a substantial shareholder of the Company. The Company is currently seeking further information and background from the relevant parties and will make further announcement(s) as and when appropriate.
